

ADMISSION NOTICE

All the students of the college (Main Branch and City Branch) are required to take note that the admissions for the Third and Fifth semesters of the Three Years programme and the Third, Fifth, Seventh and Ninth semesters of the Five Years programme shall start from Tuesday, the 15th September. The last date of the admission is 30th September. The procedure for and conditions of admission shall be as below:-

1. The students whose admissions in the first semester of the respective programme have been approved by the competent admission authority of the government of Maharashtra alone shall be eligible for the admission.
2. Student fulfilling the above condition shall download the application form and the prospectus from the website of the college, www.rtmnubacl.org
3. Those students who have backlog of any previous semester shall ascertain their eligibility by consulting the rules of ATKT as given in the prospectus and also the governing Directions of the new and the old course.
4. Those students who had admission as regular students and have filled their examination forms for summer 2020 examination, are all promoted to next semester by virtue of provisions of RTMNU'S Direction no. 12/2020, such students therefore shall attach hall tickets of their summer examinations for seeking admission in next semester.

5. Student shall remit the applicable admission fee, as specified in the prospectus, in the bank account of the college, the details of the account are as below;

Be careful that the money goes to the specified bank account of the college. Fee may be remitted through any convenient mode i.e. either in the off line mode i.e. by depositing physically in bank or through e-banking using Debit or Credit card or any other method.

Fill the application form, giving the details of the payment of the fee, and send the scanned copies of the application form along with the copies of the mark sheets of the previous semesters and proof of payment of fees, by way of e-mail. In the application form do not fail to mention your mobile number and your e-mail address.
7. The hard copy of the application form along with the mark sheets of previous semesters shall be submitted in the office of the college as and when directed.
8. As the eligibility for admission is to be ascertained by the student desiring to take admission in the college mere submission of the application form and payment of the fees shall create no obligation upon the college and hence if subsequently, on scrutiny, any student is found to be not eligible for admission his /her application for admission shall be rejected by the college after due notice.

9. The examination form shall be filled and submitted as per the procedure prescribed by the University.
10. All the admitted students shall get their College Identity Card prepared, on payment of usual fee, by the office of the college on further instructions.
