DAY WISE DETAILED REPORT

Day 1 - 25.09.2025

INNAUGURATION

The Two-Day Induction Program for newly admitted students of LL.B., B.A. LL.B., and LL.M. was inaugurated on 24th September 2025 at the hands of Hon'ble Justice Shri. Bhushan P. Dharmadhikari, Former Chief Justice of the Bombay High Court. Dr. Subhash Kondawar, Hon'ble Pro Vice Chancellor, Rashtrasant Tukadoji Maharaj Nagpur University, chaired the event.
